#### **Chapter Three**

# PROCEDURE FOR THE REGISTRATION OF TRADERS OF SEED AND PROPAGATING MATERIAL

- **Article 12.** Any natural person or legal person engaging in the trade in seed or propagating material, within the meaning of the SPMA, shall be subject to registration at the IASAS.
- **Article 13.** (1) (Supplemented, SG No. 45/2019, effective date 7.06.2019) Registration shall be carried out on the basis of an application submitted in the format which is set out in Annex No. 2 by the trader in person or by proxy to the territorial unit of the IASAS at the trader's principal

place of business. The application shall be submitted in person or by proxy or electronically pursuant to Articles 5 and 22 of the E-Government Act or via a licensed postal operator.

- (2) The following shall be attached to any such application:

- 6. (New, SG No. 26/2005) a title deed or a lease agreement for the facilities and points of sale referred to in subparagraph 5.
- **Article 14.** (1) (Supplemented, SG No. 45/2019, effective date 7.06.2019) In the cases in which the application does not comply with the established format or has other non-compliances or omissions or any document referred to in Article 13 is missing, an official of the IASAS territorial unit shall notify the irregularities to the applicant within seven days as from the receipt of the documents and give the applicant ten working days to eliminate such irregularities.

## Chapter Four KEEPING THE REGISTER; MODIFICATION OF ENTRIES

**Article 17.** (Amended, SG No. 103/2011, effective date 23.12.2011, amended, SG No. 87/2018, effective date 19.10.2018) The Executive Agency for Variety Testing, Field Inspection and Seed Control shall maintain a public national electronic register of persons trading in seed and/or propagating material on its website.

**Article 18.** The register shall contain the following details:

- 1. Registration number and date of entry into the register;

- **Article 19.** A registration file with all documents received shall be kept for each registered person.

- **Article 21.** (Amended, SG No. 87/2018, effective date 19.10.2018) (1) Registered persons shall declare any change of circumstances to the IASAS territorial unit concerned within 14 days of its occurrence.

- 2. Registration number (or number of the certificate, if any);
- 3.Description of the change of circumstances.
- (3) All documents certifying the change of circumstances shall be attached to the application referred to in paragraph 2.

**Article 26.** (1) In accordance with Article 86(2) SPMA, a trader of seed or propagating material shall be deregistered for a three-years period at an order by the Executive Director of the IASAS. # RECORDS OF THE TRADE IN SEED AND PROPAGATING MATERIAL (TITLE AMENDED, SG NO. 87/2018, EFFECTIVE DATE 19.10.2018)
